- Sylvia Faulkner spoke in opposition of the application expressing concerns with height, architectural design and incompatability with the neighbourhood.
- Jack Hanna, Centretown Community Association expressed concerns with the height noting the Urban Design Review Panel statements reflects it should be a mid-rise site with lower density and would set precedent for other projects for highrises on traditional mainstreets. This will greatly alter the character of Somerset Village.
- Marc Vanasse spoke on behalf of himself, his wife and his neighbour. Like the
 previous speakers, expressed concerns with the heigh and massing of the
 proposed development and spoke to the heritage elements of the property.
