Terri Hunt, Manager, Permit Approvals, Planning, Real Estate and Economic Development Department (PRED) and Garett Schromm, Associate Legal Counsel, Innovative and Client Services (ICS), presented an overview of the report and answered questions from the Committee. Kristina Marsh and her mother Sandra Marsh spoke to their appeal of the development charges associated with the subject property, noting that they had been informed verbally and in writing that their property had been exempt from development charges. However, when applying for a building permit were told that was misinformation and were in fact subject to development charges and are seeking compensation in the amount of \$18,953 which represents the City portion of the development charges.
