#### BACKGROUND

The City of Ottawa is a member of a number of municipal organizations, including the Association of Municipalities of Ontario (AMO), the Federation of Canadian Municipalities (FCM); the Association of Francophone Municipalities of Ontario (AFMO); the Rural Ontario Municipal Association (ROMA); the Canadian Capital Cities Organization (CCCO) and the Ontario Good Roads Association (OGRA).

On November 30, 2022, Councillor Tierney was appointed by Council as the City of Ottawa representative to FCM until the 2023 Annual Conference. Councillor Brockington is currently the AMO Council Representative; on December 7, 2022, Councillor Brockington was appointed by Council as the City of Ottawa representative to AMO until the 2022-2026 Mid-term Governance Review.

Calls for nominations from municipalities for their Boards of Directors have been received so the Nominating Committee is being asked to make recommendations for the City's representatives to the municipal organizations they support.

### **DISCUSSION**

In the past, Council had recommended the City's representatives to these organizations. This was done on an annual basis, by motion at Council. Since the 2014-2018 Term of Council, the Nominating Committee has been tasked with recommending the City's representatives to the municipal organizations they support. The 2018-2022 Nominating Committee included nominations for Council's representatives to the Federation of Canadian Municipalities, the Association of Municipalities of Ontario, the Rural Ontario Municipal Association, the Association of Francophone Municipalities of Ontario, and the Canadian Capital Cities Organization. On 7 December 2022, Council directed, via Motion, that the Ontario Good Roads Association (OGRA) be included in the Nominating Committee process as a municipal organization to which Council will appoint a representative.
