SUBJECT: Ottawa Public Library Board Ad hoc Committees

REPORT RECOMMENDATION

That the Ottawa Public Library Board approve the creation of seven Ad hoc Committees, as composed and identified in this report.

RECOMMANDATION DU RAPPORT

Que le Conseil d'administration de la Bibliothèque publique d'Ottawa approuve la création de sept comités spéciaux dont la composition est décrit dans le rapport.

BACKGROUND

In accordance with the Ottawa Public Library ("OPL" or "the Library") Board Rules of Procedure By-Law Section 42(2) "*The Board may establish ad hoc committees of limited duration, to advise, inquire, and report on a particular matter or concern. An ad hoc committee shall report on their work to the Board as required under the scope of work established through Terms of Reference, and such other provisions as the Board*

shall deem proper. Ad hoc committees dissolve automatically upon the submission of a report to the Board on the work of the matter or concern."

Ad hoc committees are generally composed of a combination of OPL staff (minimum of three; maximum of five) and two trustees. The Chair of the Board sits on all ad hoc committees in an ex-officio capacity. There is one exception to this composition: the Chief Librarian/CEO Performance Ad hoc committee consists of the Chair, Vice Chair, and one additional trustee, plus the Chief Librarian/CEO. This ad hoc committee is established for the duration of the term of the Board for oversight of the performance of the Chief Librarian/CEO.

This report provides the Board with recommendations on the creation and composition of seven ad hoc committees required at this time.

DISCUSSION

Typically, requests for creation and participation of ad hoc committees are brought forward to the Board as part of a staff report or matter before the Board. The seven ad hoc committees for the 2023 – 2026 term of the OPL Board are proposed to advise staff at this time regarding both new business and outstanding business initiated during the previous term of Board.

OPL requires the following committees to advise staff on matters initiated under the previous Board, which require support for terms estimated below. Note: staff recommend that the Order of Friendship ad hoc be incorporated into the Governance ad hoc.

- 1. Chief Librarian/CEO Performance Review (duration: term of Board);
- 2. Finance and Facilities (duration: Q1 2023 to Q4 2024);
- 3. Fund Development (duration: term of Board);
- 4. Governance (duration: term of Board);
- 5. Service Strategies, including Ādisōke (duration: Q2 2023 Q4 2024); and,
- 6. Service Channel Frameworks (duration Q2 2023-Q4 2024).

OPL requires the following new ad hoc committees to be established to advise staff within the defined mandates as noted below:

1. Branding (duration: Q1 2023 – Q3 2024). Trustees will provide staff with guidance regarding the development of a distinct and compelling brand identity.

Including advice regarding engagement components and input on design and visual identity components.

In preparing the recommendations, staff sought expressions of interest from trustees, considered the mix of citizen and councillor trustees on each committee, and considered the participation of each trustee on a minimum of one ad hoc committee. Upon further review, staff subsequently decided that given the strategic importance of the Service Strategies for OPL, three trustees are recommended for membership on this ad hoc committee.

Staff thus recommend that the Board approve participation on the ad hoc committees as follows:

- 1. Branding: Trustees Crawford and Smith;
- Chief Librarian/CEO Performance Review: Chair Luloff, Vice Chair Fisher, and Trustee King;
- 3. Finance and Facilities: Trustees Fisher and King;
- 4. Fund Development: Trustees Slack and Smith;
- 5. Governance: Trustees Bradley and Slack;
- 6. Service Strategies, including Ādisōke: Trustees Brown, Crawford, and Kitts; and,
- 7. Service Channel Frameworks: Trustees Brown and Bradley.

Next steps

Staff will be in touch with confirmed members of each ad hoc committee to establish the timeline for the first meeting.

CONSULTATION

As part of the consultation process, trustees were provided with details of the required ad hoc committees and encouraged to express interest by completing an online survey from January 27 – February 10, 2023.

ACCESSIBILITY IMPACTS

Ottawa Public Library complies with the *Accessibility for Ontarians with Disabilities Act*, (2005) in its operations. There are no accessibility impacts associated with this report.
