REPORT RECOMMENDATION

That the Board of Health for the City of Ottawa Health Unit approve the Board of Health Members' participation at the Association of Local Public Health Agencies' (alPHa) Winter Symposium, to be held February 24, 2023, and pre-symposium workshop to be held February 23, 2023.

BACKGROUND

Ottawa Public Health is an active member of the Association of Local Public Health Agencies (alPHa). alPHa provides leadership to boards of health and public health units in Ontario as well as advises and lends expertise on the governance, administration and management of health units. The Association also collaborates with governments and other health organizations, advocating for a strong, effective and efficient public health system in the province. Membership includes Board of Health Members, Medical Officers of Health and Associate Medical Officers of Health, as well as senior public health managers and affiliate members.

Participation in alPHa meetings is strongly encouraged, including by the Medical Officer of Health and/or Associate Medical Officers of Health and, whenever possible, Members of the Board of Health. alPHa regularly holds three meetings a year, including an Annual General Meeting and Conference in June as well as Fall and Winter symposiums.

DISCUSSION

On January 18, 2023, alPHa released the draft Program and BOH Section meeting agenda for its winter symposium, being held on February 24, 2023. The draft Program and BOH Section meeting agenda were circulated to Members of the Board of Health to canvas for their interest in attending this event. With a registration deadline of Monday, February 20, 2023, Board Members were asked to respond to the expression of interest by no later than Friday, February 17, 2023.

Given the timing of the circulation, the deadline for expressions of interest and registration, and the publication of the Board's January 30, 2023, meeting Agenda, this report is recommending that the Board approval Members' participation without specifically naming those Members who will be attending. Pursuant to the Board of Health Travel Policy and based on past practice, participating Members will be asked to "report back" verbally at the subsequent meeting of the Board of Health, scheduled for Monday, February 27, 2023.
