#### REPORT RECOMMENDATIONS

That the Ottawa Police Services Board (Board) approve the appointment of Ottawa Police Service (OPS) employees listed in Document 1 as Special Constables pursuant to Section 53 of the Police Services Act (PSA) and in accordance with the terms and conditions set forth in the attached Approval of Appointment Forms.

#### RECOMMANDATIONS DU RAPPORT

## **BACKGROUND**

As required in Section 53 of the Police Services Act (PSA), the Ottawa Police Services Board (Board) appoints Ottawa Police Service (OPS) employees, hired as Special Constables, and assigned to the Central Cellblock, Prison Care Unit, Court Security

Station and Document Service Team. They will work as Special Constables, upon approval by the Ministry of the Solicitor General, for a five-year period or until the appointees are no longer employed by the OPS. These appointments ensure that these employees can carry out their assigned duties as Special Constables. Upon the termination of employment, the OPS will advise the Ministry to terminate the appointments.

#### **DISCUSSION**

Approval has been obtained from the Ministry of the Solicitor General for the appointment of these OPS employees as Special Constables. Pursuant to Section 53 of the PSA, upon receipt of the Board appointment of their status, the Special Constables will be required to undertake the Oath of Office and the Oath of Secrecy by the Chief of Police.
