#### PURPOSE

The purpose of this memorandum is to report to the Transportation Committee on the use of delegated authority for 2022.

#### BACKGROUND

A new Delegation of Authority By-law (2022-29) was enacted by Council on February 9, 2022, which reflects the new corporate structure with Traffic Services being realigned into Public Works and Environmental Services Department (PWES) and Transportation Planning into the Planning, Real Estate and Economic Development Department (PRED). As a result, future Use of Delegated Authority reports will be brought forward by each respective department to Transportation Committee.

#### DISCUSSION

Transportation Planning reports to the Transportation Committee. To meet the reporting requirements as identified in Schedule "J" Transportation Services By-Law 2022-29 which was in effect in 2022, the Service Area has produced a consolidated list which highlights their use of delegated authority during that time period (see Document 1).

#### CONCLUSION

Transportation Planning within its new respective Department will continue to report to Transportation Committee once per year on their use of delegated authority as per the current Delegation of Authority By-law (2022-29).

**Document 1 – 2022 Delegated Authority under Transportation Planning -  
Schedule “J” Planning, Real Estate and Economic Development Department  
By-Law 2022-29**

**Transportation Planning Services – Capital Projects**

The following roadway modifications were approved in 2022, under Section 44 – Intersection and Road Modifications of Schedule “J” of By-law 2022-29. The functional planning for these projects were led by the Transportation Planning Service Area, which also include projects stemming from Integrated Road-Water-Sewer Renewal, Intersection Control Measures and Network Management programs. These are all projects with Council-approved capital budgets. Infrastructure Services in the Infrastructure and Water Services Department manages the detailed design and construction of these projects, as well as the capital budget of the renewal program.

The Road Modification Authority (RMA) reports reflect the modifications that need to be made to a road or a traffic intersection in response to the impacts of a Development or the capital program. Intersection and Road Modifications fall under the Delegated Authority of the GM of PRED and the Director of Transportation Planning and must have the concurrence of the local Ward Councillor.
