1. AUDITOR'S REPORT – COMPLIANCE AUDIT OF THE CAMPAIGN FINANCES OF CANDIDATE LAURA DUDAS FOR INNES WARD FOR THE 2018 REGULAR ELECTION

That, pursuant to section 88.33(17) of the *Municipal Elections Act, 1996*, the Election Compliance Audit Committee consider this report and decide whether to commence a legal proceeding against Candidate Laura Dudas for Innes Ward for an apparent contravention.

[Note: The 30-day timeline under the *Municipal Elections Act, 1996* for the Committee to consider and decide this matter expires on Monday, March 30, 2020.]

The Chair read an opening statement outlining the procedures for and format of the Committee Meeting.

Marco Perron, the Auditor appointed by the Committee in this matter, and Paul Maniscalco of Raymond Chabot Grant Thornton, presented the Auditor's Report and answered questions from the Committee.

The Applicant, Ms. Heather Buchanan, was absent, and provided no additional written submissions further to her Application.

The Candidate, Laura Dudas, was in attendance, along with her representative, Gregory Meeds of Vice & Hunter LLP. Mr. Meeds spoke to the Committee opposing the commencement of a legal proceeding against the Candidate, and provided a written submission to the Committee which is filed with the City Clerk's Office. Mr. Meeds and Candidate Dudas answered questions from the Committee.

Tyler Cox, Manager, Legislative Services, also answered questions from the Committee

The Committee then recessed to deliberate in private and, upon being called to order, considered the following motion:

BE IT RESOLVED THAT the Committee issues the following decision and reasons:

Upon receiving the compliance audit report with respect to the election campaign finances of the candidate Laura Dudas from the appointed auditor, hearing the representations and/or reading the written submissions and documents submitted by the Auditor, the Candidate, her representative, and City staff, this Committee hereby decides to commence legal proceedings against the candidate for an apparent contravention of the provisions of the *Municipal Elections Act, 1996* relating to election campaign finances for the following reasons:

The Auditor's report identifies a number of apparent contraventions of the provisions of the *Municipal Elections Act* financial campaign provisions. These apparent contraventions were supported by the Auditor's extensive examination of documents and witness interviews listed in the report.

The apparent contraventions are too numerous and give the Committee concern that the values of public accountability and transparency have not been respected during Ms. Dudas' campaign.

The apparent contraventions of this number are inconsistent with the maintenance of public confidence in the integrity of the electoral

The candidate's stated ignorance of the various expenses incurred for her campaign's benefit undercuts the requirement of candidate accountability which lies at the heart of the act's election campaign finance provisions.

The Committee directs the City Clerk to work with the City Solicitor to implement this decision, including retaining external legal counsel to have all the usual power and authority of a prosecutor for the purpose of the legal proceeding.

The Committee then CARRIED the motion.
