The Chief noted that OPS works with CSIS and RCMP on a regular basis and the Service is committed to an ongoing relationship with Muslim community leaders. The OPS increased their Hate Crime Unit by one member and have assisted mosques with safety presentations. The Service will also be participating in a Ramadan Iftar ceremony in the coming weeks.

#### 8.10 EDI Action Plan Update

Chief's report

Supt. Zacharias provided a presentation to the Board.

A few comments were made with respect to topics not included in the plan such as mental health, housing, addictions, asylum seekers, representativeness of the Service's membership as compared to the community, unconscious bias training, accessibility, and reconciliation.

It was confirmed that the OPS will be developing KPIs to ensure strong governance around the plan.

The OPS noted they were reviewing their recruitment processes to ensure they are equitable. In terms of the narrowing of priorities to four, the Service noted a number of recommendations have been made over the years around EDI and there is flexibility in the plan in order to adjust as needed. Capacity to deliver is also a consideration.

A suggestion was made to have the OPS think about possible progress indicators that would be of interest to the Board, that could be included in a dashboard for tracking.

# 8.11 Quality Assurance Annual Report 2022 (Compliance with Ministry Standards)

#### Chief's report

#### 8.12 Financial Status Report - Fourth Quarter 2022

Chief's report

It was clarified that the OPS cannot carry a deficient or a surplus, under the PSA. Any deficits are covered by the City's Tax Stabilization Reserve. Over the last 10 years, the Service has finished the year with a deficit approximately 60% of the time, and a surplus 40% of the time. The Service does not track how much it obtains from the Reserve versus puts in, over the years.

It was noted that overtime costs will continue to be a problem and this may need to be reviewed as part of the Board's strategic planning.
