Committee voted on the motions below as follows:

Motion No. 2022-27-1

Moved by Phillip Turcotte

WHEREAS the availability of wheelchair and mobility deviceaccessible taxicabs (accessible taxicabs) is essential to the full inclusion of disabled residents and disabled visitors in Ottawa;

WHEREAS it has been well established that the sustainability and attractiveness of the accessible taxicab market is on the decline in Ottawa, as is the availability of accessible taxicabs compared to nonaccessible taxicabs; WHEREAS news media have recently reported on instances where disabled passengers have been left stranded to the lack of available on-demand accessible taxicabs;

WHEREAS according to those same media reports, it appears that taxicab drivers have a practice of not accepting service request by disabled clients for accessible taxicabs;

WHEREAS disabled Ottawans have indicated to the Accessibility Advisory Committee (AAC) that taxicab companies have denied them the opportunity to book an accessible taxicab in advance, despite the fact that non-disabled Ottawans are able to book taxicabs in advance;

WHEREAS the right of disabled clients to taxicab services without discrimination on the basis of their disability is protected under the Ontario Human Rights Code; and

WHEREAS the present situation appears to be contrary to Ottawa's obligations under s. 79 of the Integrated Accessibility Standards, O. Reg. 191/11.

THEREFORE BE IT RESOLVED THAT the AAC calls on City Council and city staff to act immediately to address the availability of accessible taxicab cabs in Ottawa by, amongst other things:

- i. Ensuring that accessible taxicabs are on the road and available to take on-demand requests twenty-four hours a day, seven days a week, on par with non-accessible taxicabs;
- ii. Ensuring that accessible taxicab drivers are not allowed to decline service requests for an accessible taxicab; and
- iii. Ensuring that taxicab companies are required to offer the same level and quality of service to disabled and non-disabled clients alike, including the advance booking of taxicabs;

BE IT ALSO RESOLVED THAT the AAC calls on City Council to take additional, immediate measures to incentivize and sustain the accessible taxicab market in Ottawa.

Moved by Phillip Turcotte

WHEREAS, in 2016, City Council adopted the Vehicle for Hire By-Law, By-law No. 2016-272 which, amongst other things permits the operation of Private Transportation Companies" (PTCs), like Uber and Lyft, to operate in Ottawa;

WHEREAS, despite recommendations to the contrary by some members of the Accessibility Advisory Committee and disabled communities in Ottawa more broadly, the Vehicle for Hire By-Law allows PTCs to operate in Ottawa without providing services to persons with disabilities who would require an accessible PTC vehicle capable of accommodating a wheelchair or mobility scooter;

WHEREAS, PTCs in other municipalities across North America do provide services to disabled persons who require an accessible PTC vehicle;

WHEREAS the Vehicle for Hire By-Law excludes disabled residents and tourists in Ottawa from a class of service otherwise available to non-disabled residents and tourists;

WHEREAS initiatives like the Vehicle-for-Hire Accessibility Fund, while well-intentioned, only further reinforce the exclusion of disabled residents and tourists from a class of service otherwise available to non-disabled residents and tourists; and

WHEREAS this exclusion is Ableist and contrary to the sprit and intent of the Accessibility for Ontarians with Disabilities Act, 2005, and the building of an inclusive and disability-positive city;

THEREFORE BE IT RESOLVED that the AAC call on City Council to amend the Vehicle for Hire By-Law to require PTCs to provide services to disabled persons by way of accessible PTC vehicles; and BE IT ALSO RESOLVED THAT the AAC call on the City to immediately enter into discussions with PTC providers to encourage them to willingly provide these services pending regulatory changes.

Motion No. **2022-27-3** Moved by Phillip Turcotte WHEREAS access to quality, reliable, and accessible public transportation options is vital to the full inclusion and participation of disabled residents in Ottawa;

WHEREAS Para Transpo is meant to provide a level of inclusionary public transit service that OC Transpo's bus service cannot;

WHEREAS Para Transpo's door-to-door service for qualifying disabled residents is an essential service;

WHEREAS despite the fact that Para Transpo offers a different kind of service than OC Transpo, it nonetheless forms part of Ottawa's public transit infrastructure and is a critical component of that infrastructure;

WHEREAS OC Transpo buses in Ottawa generally provide services twenty-four hours a day, seven days a week;

WHERAS Para Transpo does not provide services twenty-four hours a day, seven days a week, leaving disabled residents without equitable access to public transit; and

WHEREAS this inequity promotes the segregation of disabled residents and leaves them unable to fully enjoy the city on par with non-disabled residents.

THEREFORE BE IT RESOLVED THAT the Accessibility Advisory Committee (AAC) calls on City Council to direct that Para Transpo's services be made available twenty-four hours a day, seven days a week, without delay; and

BE IT ALSO RESOLVED THAT the AAC calls on City Council to properly staff and resource Para Transpo to make such level of service practicable and sustainable.
