PURPOSE OF THE APPLICATIONS:

The Owners wants to subdivide their property into two separate parcels of land for the construction of a new two-storey semi-detached dwelling, with one unit containing a secondary dwelling unit. The existing dwelling is to be demolished.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owners require the Consent of the Committee for Conveyances.

The severed land, shown as Part 1 on the draft 4R-Plan filed with the application, will have a frontage of 7.62 metres on Prince Albert Street, a depth of 28.09 metres and will contain a lot area of 213.8 square metres. This parcel will contain one half of the proposed semi-detached dwelling and will be known municipally as 106A Price Albert Street.

The retained lands, shown as Part 2 on said draft plan, will have a frontage of 7.62 metres, a depth of 27.89 metres and will contain a lot area of 213.4 square metres. This parcel will contain the other half of the proposed semi-detached dwelling and will be known municipally as 106B Prince Albert Street.

Approval of these applications will have the effect of crating two separate parcels of land. The proposed development will not be in conformity with the requirements of the Zoning By-law and therefore, Minor Variance Applications D08-02-23/A-00050 & D08-02-23A-00051 have been filed and will be heard concurrently with these applications. **THE APPLICATIONS** indicate that the Property is not the subject of any other current application under the *Planning Act*.

YOU ARE ENTITLED TO PARTICIPATE in the Committee of Adjustment Public Hearing concerning these applications because you are an assessed owner of one of the neighbouring properties. See Annex A – Public Participation Details on providing written submissions or verbal comments in advance of the hearing, and how to register to speak at the hearing. The Committee asks that any presentations be limited to five minutes or less, and any exceptions will be at the discretion of the Committee Chair. You may require the Committee to hold the hearing as an oral (in person) hearing if you satisfy the Committee that holding the hearing as an electronic hearing is likely to cause you significant prejudice. To do so, you must provide written submissions to the Committee at least 48 hours in advance of the hearing.

IF YOU DO NOT PARTICIPATE in this Public Hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings. If you have specific comments regarding these applications, you may submit a letter to the Secretary-Treasurer of the Committee at the address shown below, and such written submissions shall be available for inspection by any interested person. Information you choose to disclose in your correspondence, including your personal information, will be used to receive your views on the relevant issues to enable the Committee to make its decision on this matter. The information

provided will become part of the public record. Every attempt should be made to file your submission five days prior to the Public Hearing date.

IF YOU WISH TO BE NOTIFIED of the Committee's decision, you must make a written request to the Secretary-Treasurer at the address below. Only the applicant, the Minister or a specified person or public body that has an interest in the matter may appeal the decision to the Ontario Land Tribunal. A "specified person" does not include an individual or a community association.
