APPLICANT’S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owner wants to build an accessory structure (agricultural storage building) within a flood plain, as shown on the plans filled with the committee.

REQUESTED VARIANCE:

The Owner requires the Committee’s authorization for a minor variance from the Zoning By-law to permit an accessory structure with a gross floor area of 442 square metres to be constructed in a floodplain, whereas the By-law prohibits accessory structures greater than 50 square metres in gross floor area within the floodplain.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
