## APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Applicant wants to subdivide the property into two separate parcels of land to create separate ownerships for each half of an existing semi-detached dwelling, as shown on plans filed with the Committee.

## CONSENT IS REQUIRED FOR THE FOLLOWING:

The Applicant requires the Consent of the Committee for a Conveyance.

The severed land, shown as Part 2 on a draft 4R plan filed with the application, will have frontage of 10.06 metres on Foxview Place, a depth of 35.29 metres and will contain a lot area of 355.02 square metres. This parcel will contain one half of the semi-detached dwelling, known municipally as 574 Foxview Place.

The retained land, shown as Part 1 on said plan, will have frontage of 10.06 metres on Foxview Place, a depth of 35.28 metres and will contain a lot area of 354.92 square metres. This parcel will contain the other half of the semi-detached dwelling, known municipally as 572 Foxview Place.
