#### APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owners want to construct a one-storey addition at the rear (northwest corner) of their detached dwelling, replacing an existing covered porch, as shown on plans filed with the Committee.

#### **REQUESTED VARIANCE:**

The Owners require the Committee's authorization for a Minor Variance from the Zoning By-law to:

a) permit a reduced total interior side yard setback of 1.37 metres, with one side being 0.49 metres, whereas the By-law requires a minimum total interior side yard setback of 1.8 metres with no side less than 0.6 metres.

b) Permit a reduced front yard setback of 2.07 metres, whereas the By-law requires a minimum front yard setback of 3.0 metres.

**IF YOU DO NOT PARTICIPATE** in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

**IF YOU WANT TO BE NOTIFIED OF THE DECISION** following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

## COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario <u>Planning Act</u>. Each year, it holds hearings on hundreds of applications under the Planning Act in accordance with the Ontario <u>Statutory Powers</u> <u>Procedure Act</u>, including consents to sever land and minor variances from the zoning requirements.
