Report Recommendation(s)

The Agriculture and Rural Affairs Committee recommends Council approve the following:

1. Authorize the City and delegate authority to the General Manager, Planning, Real Estate and Economic Development Department, to enter into a Front-Ending Agreement (the "Agreement") with Minto Communities Inc. in relation to the design and construction of the Manotick Watermain Link

Phase 2 project, as outlined in this report, in accordance with the Front-Ending Agreement Principles and Policy set forth in Documents 1 and 2 and with the final form and content being to the satisfaction of the City Solicitor;

- Pursuant to said Agreement, authorize the receipt from Minto Communities Inc. to an upset limit of \$12,800,212 plus applicable taxes in accordance with the Agreement, to fund the above-described work which are to be completed by the City;
- Pursuant to said Agreement, upon receipt of the abovedescribed funds, authorize the City to tender drawings and specifications for the said works and provide contract administration and site inspection for their construction; and
- 4. Pursuant to said Agreement, authorize financial disbursement to reimburse Minto Communities Inc. by way of Development Charge Credits to an upset limit of \$12,800,212 plus applicable taxes through the Manotick Area Specific Development Charges and in accordance with said Agreement.
