APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION(S):

The Owner wants to subdivide the property into three separate parcels of land for the construction of a semi-detached dwelling and a detached dwelling, all with secondary dwelling units.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Applicant requires the Committee's consent to sever the land. The property is shown as Parts 1 to 4 on a Draft 4R-Plan filed with the applications, and the separate parcels will be as follows.

The retained lands, shown as Part 3 on the draft 4R-plan will have a frontage of 26.24 metres, a depth of 25.65 metres and a lot area of 363 square metres. This parcel will contain the new detached dwelling and be known municipally as 20 Inverkep.

The application indicates that the property is subject to existing Easements and Right-of-Ways as in Instrument Nos. OC30350, OC30353, OC32903, OC37321, OC103259, OC103259, and OC103259

Approval of these applications will have the effect of creating three separate parcels of land, one of which will not be in conformity with the requirements of the Zoning By-law and a Minor Variance Application (D08-02-23A-00110) has been filed and will be heard concurrently with these applications.

REQUESTED VARIANCES:

The Owner requires the Committee's authorization for a Minor Variances from the Zoning By-law as follows:

A-00110: 20 Inverkep, Part 3 on 4R detached dwelling:

a) To permit a reduced interior yard area of 30.78 square metres, whereas the Bylaw requires a minimum interior yard area of 49.5 square metres.
