APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Application is seeking a Certificate of Validation of Title to correct a title error which resulted in the current owner not having legal title to his property.

The property and the adjacent property at 68 Lavergne Street were always two separate properties for planning purposes. In 1965, Andre Drouin purchased 68 & 72 Lavergne Street from the previous Owner, Dependable Finance Corporation Limited, and as a result, the two properties were merged for *Planning Act* purposes. In 2003, Mr. Drouin transferred 72 Lavergne Street to Evan Legg alone. That transfer contravened the *Planning Act*.

The Validation of Title relates to the Property described as Lot 51, Registrars Complied Plan 908.

Caisse Desjardins Ontario Credit Union Inc. is now seeking to validate the title of the properties and an accompanying Validation of Title application (D08-01-23/T-0001) has been filed for 68 Lavergne Street.
