**APPLICANT’S PROPOSAL AND PURPOSE OF THE APPLICATION:**

The Owner wants to convey a portion of its property to the abutting property owner to the east, known municipally as 340 Terry Fox Drive, to accommodate the current surface parking.

**CONSENT IS REQUIRED FOR THE FOLLOWING:**

The Owner requires the Committee’s consent for a lot line adjustment. The property is shown as Part 1 on a Draft 4R-Plan filed with the application and the separate parcels will be as follows:

The severed land, shown as Part 1 on draft 4R-plan, will contain a lot area of 2,653 square metres. The vacant land will merge with the property to the east, known municipally as 340 Terry Fox Drive.

The retained land, as shown on a sketch, will have frontage of 186.42 metres on Terry Fox Drive, an irregular depth and will contain a lot area of 2.15 hectares. This parcel will be known as 105 Helmsdale Drive.

**IF YOU DO NOT PARTICIPATE** in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

**IF YOU WANT TO BE NOTIFIED OF THE DECISION** following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
