## Instructions

Under the Municipal Elections Act, 1996 (the "MEA"), any eligible elector who believes that a candidate or registered third party advertiser has contravened the campaign finance rules in the statute may apply for a compliance audit of that party's election campaign finances.

To apply for a compliance audit of a candidate for the office of Mayor or City Councillor, or a registered third-party advertiser:

1. Complete this form and the required fields marked with an asterisk (*).
2. Submit this form and any supporting documents in person at the City of Ottawa's Elections Office during regular business hours (Monday to Friday from 8:30 am to 4:30 $\mathrm{pm})$.

The Elections Office must receive this form by the deadlines) prescribed in Subsection 88.33(3) or Subsection 88.35(3) of the MEA.

All applications will be submitted to the Election Compliance Audit Committee for review in accordance with the MEA.

## Shawn MENARD- Form 4

Spending limit for Capital Ward 2022 Municipal Election: \$29508.90

Declared expenses for Shawn MENARD's 2022 campaign: \$27199.10

Campaign declared it underspent by $\$ 2309.80$ from allotted maximum
The MENARD campaign claimed a 2022 expense of $\$ 2576.55$ for signs (including sign deposit)

As per the Municipal Elections Act of Ontario, 1996;
"If you ran in the last municipal council or school board election and you want to reuse leftover goods such as signs or office supplies you must establish the current market value of the goods - what it would cost you to purchase them today. You must record the current market value as an expense."

Schedule 1 of Form 4 Financial Statement Auditor's Report Candidate-declares the results of Table 2: Inventory of campaign goods and materials from previous municipal campaign used in this campaign

The MENARD campaign declares $\$ 2190.50$ as the value of the below items carried over from a previous campaign:

600 H-Frames for signs (2018 election), total value $\$ 678.00$ ( \$1.13/unit)
250 small signs (2018 election), total value $\$ 1412.50$ ( $\$ 5.65 /$ unit)
Sign Material (screws and zip ties) (2018 election), total value \$100

In this video between 0:08-0:13 two large election signs with the candidates face along with similar colours to the candidates signs previously noted can be observed. For context of the size of these signs, 2 concrete "deck blocks" can be seen partially holding one of the signs up. Approximately 2-3 more would be needed to cover the entire length of these signs.

## Observations:

The candidate claims on OCT 072022 to have over 500 signs up throughout the Ward. The candidate declared 250 signs from a previous election were used in his 2022 campaign The candidate declared the use of 600 "H-Frames for signs" from a previous election were used his 2022 campaign
The candidate posted a video of new small signs being made on SEP 30. 2022
By declaring the carry-forwarded of 600 H -Frames and his claim of over 500 signs "up throughout the Ward" a reasonable person could come to the conclusion that the candidate's campaign ordered 350 new small signs for use (or at a minimum 251 new signs, given the above comment)
If the campaign purchased at a minimum only 251 new signs at $\$ 5.65$ / each this would total \$1418.15
The candidate's campaign displayed larger signs with the candidates face at the campaign "kick-off" on SEP 06, 2022
These larger signs were also observed by the public on public property throughout the campaign.
It is unreasonable to believe that these larger signs only cost the campaign $\$ 1158.40$ (declared value of signs of $\$ 2576.55$ minus the liberal cost of $\$ 1418.15$ for 251 new smaller signs) The candidate declared a carry-over value of sign material (screws and zip ties) from the 2018 election of \$100.00
The larger signs previously mentioned require a stable base such as wood or plastic for display. The candidate does not appear to have accounted for the materials needed to display these larger signs which were placed on public property during the election period.

## SUMMARY:

Shawn Menard's campaign did not adequately account for all his new sign expenditures for the 2022 Ottawa Municipal Election. Mr. Menard himself acknowledged that he put over double (500 plus) the amount of lawn signs he claimed as a carry-forward from the 2018 campaign. In addition, Mr. Menard's campaign had larger signs on display at events and on public property in the 2022 campaign. These were not listed as being carried forward from 2018 and therefore would be new expenditures for his 2022 campaign.

A reasonable person would come to the conclusion that to purchase an additional 250+ lawn signs, new larger signs and the subsequent hardware needed to erect these signs would cost more than the declared 2022 expenditure of $\$ 2576.55$ listed on Shawn Menard's Financial Statement- Auditor's Report Candidate- Form 4.
