APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATIONS:

The Owners want to construct a two-storey rear addition as well as a covered front porch at the front of both properties.

REQUESTED VARIANCES:

The Owners require the Committee's authorization for a Minor Variances from the Zoning By-law as follows:

A-00105: 248 Bayswater Avenue

- a) To permit a reduced rear yard setback of 6.5 metres, whereas the By-law requires a minimum rear yard setback of 7.5 metres.

- b) To permit a reduced interior side yard setback of 1 metre, whereas the By-law requires a minimum interior side yard setback of 1.2 metres.
- c) To permit a parking space to be located in the front yard, whereas the By-law does not permit parking in a required and provided front yard.

A-00130: 250 Bayswater Avenue

- d) To permit a reduced rear yard setback of 6.5 metres, whereas the By-law requires a minimum rear yard setback of 7.5 metres.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
