APPLICANT’S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owner wants to convey a portion of its property to the abutting property owner to the north, known municipally as 290 Mount Nebo Way.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owner requires the Committee’s consent to for a lot line adjustment.

The land to be severed shown as Part 1 on the Draft 4R Plan filed with the application, will have a frontage of 10.80 metres, a depth of 33.80 metres, and a lot area of 365.2 hectares. This vacant land will merge with the property to the north, known as 290 Mount Nebo Way.

The land to be retained, shown on the said plan, will have frontage of 10.20 metres, an irregular depth and a lot area of 1055.31 hectares. This parcel contains a two-storey dwelling will be known municipally as 316 Memorial Grove.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
