APPLICANT’S PROPOSAL AND PURPOSE OF THE APPLICATION(S):

The Owner wants to convert the existing stacked dwelling to a low-rise apartment building with the addition of a three-story addition at the rear of the existing dwelling, which will contain four additional dwelling units, for a total of 10 units, as shown on plans filed with the Committee.

REQUESTED VARIANCE:

The Applicant requires the Committee’s authorization for a Minor Variance from the Zoning By-law to permit a reduced rear yard setback of 2.94 metres (18.24% of the lot depth), whereas the By-law requires a minimum rear yard setback of 4.03 metres (25% of the lot depth).

The application indicates that the front lot line is on Devonshire Lane.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
