## 4.1 OPS Briefing on Use of Force

Motion M-20-09 Briefing on Use of Force

Presentation

OPS staff made a presentation to the Committee, followed by a discussion and questions by the Committee.

In terms of disparities in use of force involving racialized communities, a question was raised as to how bias can be removed. The Service noted it had engaged community partners through the Community Equity Council to help look at the OPS's data as a whole. The Service is also continuing its works with academics to help address that question. The OPS will be looking to set targets in collaboration with its partners assisting on this issue.

On the topic of dynamic entries, it was clarified that all search warrants are issued by a Justice of the Peace or a Judge, providing oversight of the approval. It then goes to the Critical Incident Commander (CIC) who determines tactics/techniques and assesses risk and totality of circumstances. The CIC is in charge of the operation. In terms of reporting to the Board, it was suggested the Board would be more interested in seeing any trend lines, rather than receiving reports of individual incidents.

In cases where a member is charged under the Criminal Code for use of force, it was confirmed that the Service files a review to see what occurred.

The Chief commented on the caliber and efficacy of the team working at the OPS Professional Development Centre.

It was suggested that Section 1.4 could be further expanded to note that if the Chief were to reject or disagree with a recommendation of the Board, the Chief would be required to provide a rationale as to why.

There was also a suggestion to incorporate some of the content from the policy from Halton, particularly 2.2 and 2.3.

The Committee directed the ED to work with OPS Legal on further amending the policy.

That the Ottawa Police Services Board's Policy and Governance Committee review Board Policy CR-17 Major Events and endorse the recommended changes for Board approval.
