I this ward only City-owned trees are protected under the tree by-law, and would require a Tree Information Report. In this case there are no City trees on site, so a TIR would not be required.


Please note, however, that the applicant is responsible for protecting any trees on adjacent properties, regardless of the tree by-law, and there may be impacts to trees along the property line shared with 794 which would need to be worked out between the owners. It appears that the proposed swale is well within the Critical Root Zones of the trees along the edge of the adjacent property.
