APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owners want to construct a two-car garage in the same location as the existing carport, which will be demolished, as shown on plans filed with the Committee.

At its hearing on October 19, 2022, the Committee adjourned the application to allow the Owners time to revise their site plan and file a Cultural Heritage Impact Statement. It has since been determined that the Cultural Heritage Impact Statement is not required. The Owners now want to proceed with the application.

REQUESTED VARIANCES:

The Owners require the Committee's authorization for minor variances from the Zoning By-law as follows:

- a) To permit a reduced southerly interior side yard setback of 0.91 metres, whereas the By-law requires a minimum side yard setback of 3.
- b) To permit a reduced front yard setback of 3.5 metres, whereas the By-law requires a minimum front yard setback of 5 metres.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
