APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATIONS:

The Owner wants to sever their property into two new parcels of land for the construction of a new two-storey detached dwelling. The existing dwelling will remain.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owner requires the Committee's consent to sever.

The property is shown as Parts 1, 2 and 3 on the Draft 4R-Plan filed with the applications and the separate parcels will be as follows:

Approval of these applications will have the effect of creating separate parcels of land. One of the proposed parcels and new detached dwelling will not be in conformity with the requirements of the Zoning By-law and therefore, minor variance application (File No. D08-02-23/A-00181) has been filed and will be heard concurrently with this application.

REQUESTED VARIANCES:

The Owner requires the Committee's authorization for minor variances from the Zoning By-law as follows:

- a) To permit a reduced lot width of 15.6 metres, whereas the By-law requires a minimum lot width of 18 metres.
- b) To permit a reduced lot area of 534.7 square metres, whereas the By-law requires a minimum lot area of 665 square metres.
- c) To permit a reduced front yard setback of 5.4 metres, whereas the By-law requires a minimum front yard setback of 6 metres.
- d) To permit an increased projection for a canopy (over the front entrance) of 3 metres, whereas the By-law requires permits a canopy to project a maximum of 1.8 metres.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

Information you choose to disclose in your correspondence, including your personal information, will become part of the public record, and shared with Committee Members, the Applicant(s) or their agent, and any other interested individual.

You will receive details on how to participate by videoconference. If you want to share a visual presentation, the Coordinator can provide details on how to do so. Presentations are limited to five minutes, and any exceptions are at the discretion of the Chair.

Hearings are governed by the Committee of Adjustment's *Rules of Practice and Procedure* accessible online.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
