## BACKGROUND

The Investigation of the Manotick Business Improvement Area (MBIA) Expenses was undertaken as a result of a report made to the Fraud and Waste Hotline.

## DISCUSSION

The OAG received allegations in relation to potential inappropriate expenses incurred by the MBIA and undertook an investigation. The MBIA Board of Management (Board) is responsible for managing the affairs of the MBIA and fulfilling the requirements of applicable municipal by-laws and related policies. As such, the results of our investigation related to the MBIA's expenses were reported to the MBIA Board on September 8, 2023. The **Investigation of Manotick Business Improvement Area Expenses** report is provided to the Committee for information purposes (Document 1).

As part of the investigation, we identified areas of improvement for the City as it relates to the support it provides to Business Improvement Areas (BIA). As such, in accordance with the Governance report approved by Council on December 7, 2022, the **Investigation of Manotick Business Improvement Area Expenses – Role of the City** is being tabled with the Audit Committee. The report will then be referred to Council for approval of the audit recommendations. Details of the investigation objective, scope, findings, recommendations, and management action plans can be found in the investigation report (Document 2).

In addition to the detailed investigation reports, we have developed a one-page summary of key highlights from our investigation (Document 3).
