APPLICANT'S PROPOSAL / PURPOSE OF THE APPLICATIONS:

The Owner wants to subdivide its property into two separate parcels of land for the construction of two, three-storey long semi-detached dwellings, each with secondary dwelling units. The existing dwelling will be demolished.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owner requires the Committee's consent for conveyances, grants of easements/rights of way and a joint-use and maintenance agreement. The property is shown as Parts 1-4 on a Draft 4R-Plan filed with the applications and the separate parcels will be as follows:

It is proposed to establish easements/rights of way as follows:

- Easement over Part 2 in favor of Part 3 & 4 for access and maintenance.
- Easement over Part 3 in favor of Part 1 & 2 for access and maintenance.

Approval of these applications will have the effect of creating separate parcels of land that will not be in conformity with the requirements of the Zoning By-law and therefore, Minor Variance Applications (File Nos D08-02-23/A-00196 & D08-01-23/A-00197) have been filed and will be heard concurrently with these applications.

REQUESTED VARIANCES:

The Owners/Applicants requires the Committee's authorization for minor variances from the Zoning By-law as follows:

A-00196: 58 Lees Avenue, Parts 1 & 2 on Draft 4R Plan

- a) To permit a reduced lot width of 7.93 metres, whereas the By-law requires a minimum lot width of 10 metres.
- b) To permit a reduced lot area of 245.9 square metres, whereas the By-law requires a minimum lot area of 300 square metres.

A-00197: 60 Lees Avenue, Parts 3 & 4 on Draft 4R Plan

- c) To permit a reduced lot width of 7.93 metres, whereas the By-law requires a minimum lot width of 10 metres.
- d) To permit a reduced lot area of 244.7 square metres, whereas the By-law requires a minimum lot area of 300 square metres.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
