APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owner wants to construct a semi-detached dwelling, each with an additional dwelling unit, as shown on plans filed with the Committee.

REQUESTED VARIANCES:

The Owner requires the Committee's authorization for minor variances from the Zoning By-law as follows:

- a) To permit a reduced lot area of 151.5 square metres, whereas the By-law requires a minimum lot area of 270 square metres.

- b) To permit an increased building height of 10.93 metres, whereas the By-law permits a maximum building height of 8 metres.
- c) To permit a reduced front yard setback of 3.09 metres, whereas the By-law requires a minimum front yard setback of 6 metres.
- d) To permit a reduced westerly interior yard setback of 1.25 metres, whereas the By-law requires a minimum interior side yard of 1.5 metres.
- e) To permit a reduced corner side yard setback of 3.05 metres, whereas the By-law requires a minimum corner side yard of 4.5 metres.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
