APPLICANTS' PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owners want to construct an attached garage with workshop on the north side of and a one storey addition at the front of the house to accommodate a vestibule, mudroom, and two-piece washroom, as shown on plans filed with the Committee.

REQUESTED VARIANCES:

The Owners/Applicants requires the Committee's authorization for a minor variance from the Zoning By-law as follows:

- a) To permit a reduced front yard setback of 5.25 metres, whereas the By-law requires a minimum front yard setback of 6.0 metres.
- b) To permit a reduced total interior side yard setback of 2.4 metres (0.6 metres on the north side and 1.8 metres on the south side), whereas the By-law requires a minimum total interior side yard setback of 3 metres, with no yard less than 1.2 meters.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
