**APPLICANT’S PROPOSAL AND PURPOSE OF THE APPLICATION:**

The Owners want to subdivide their property into two separate parcels of land to create one new lot for future development. The existing detached dwelling will remain.

**CONSENT IS REQUIRED FOR THE FOLLOWING:**

The Owners require the Committee’s consent to sever. The severed land, shown on a sketch filed with the application, will have a frontage of 103.8 metres, a depth of 1038.7 metres, and will contain an area of 10.6 hectares. This parcel is vacant and will be municipally known as 4174 William McEwen Drive.

The retained land, shown on the sketch, will have a frontage of 103.8 metres, a depth of 1036.5 metres, and an area of 10.7 hectares. This parcel contains the existing detached dwelling and accessory buildings, known municipally as 4160 William McEwen Drive.

The application indicates that the property is subject of an existing easement as in CR384004.

**IF YOU DO NOT PARTICIPATE** in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

**IF YOU WANT TO BE NOTIFIED OF THE DECISION** following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
