- 2. Marc Sauve, Metcalfe Community Association also expressed concerns with increased truck traffic and how the traffic flow could be alternately routed.
- 3. Anne Parsons expressed concerns with the proposal and the increase in truck traffic.
- 4. Lynda Muckle noted approving this application to rezone to allow for industrial use will set a precedent in the rural community, also expressing concerns with the increase in truck traffic as a result.
