WHEREAS the Statement of Cultural Heritage Value attached as Document 5 outlines the heritage value of the property;

WHEREAS the adaptive reuse of this property over the course of its history contributes to an understanding of the character of Sandy Hill;

WHEREAS The adaptation of the former École St- Pierre into a community centre reflects the community's efforts in using municipal interventions to protect Ottawa's built Heritage and its subsequent adaptation into a multi-unit residence reflects the contemporary community character.

THEREFORE BE IT RESOLVED THAT, with respect to report ACS2023-PRE-RHU-0004, the Statement of Cultural Heritage Value, attached as Document 5 be replaced with the new Document 5 attached

Be it further resolved that the Statement of Cultural Heritage Value be amended to include the pioneering role played by the Community Associations and City of Ottawa in the 1970's to conserve Ecole St Pierre and the founding of legislation, policies and programs to conserve Ottawa's disappearing built heritage".
