WHEREAS the City of Ottawa has not yet undertaken a comprehensive inventory and evaluation of Ottawa's "mid-century modern" architecture; and,

WHEREAS the classification of buildings constructed in the "midcentury modern" period cannot be classed as "unique" or "excellent" examples until a comprehensive inventory of their contemporaries has been systematically completed.

WHEREAS in the interim, the use of the term "representative" should be used as permitted in Ontario Regulation 09/06;

THEREFORE BE IT RESOLVED THAT the Statement of Cultural Heritage Value listed as Document 5 of this report be amended as follows:

"The Crabtree House has design value as an excellent example of modernist residential architecture in Ottawa" **be replaced with** "The Crabtree House has design value as a <u>representative</u> example of modernist residential architecture in Ottawa."
