Public delegations spoke to a lawsuit against the Board concerning changes it made to its Procedure Bylaw around the hearing of delegations, as well as the South Facility project.

A question was raised concerning the reaction of Barrhaven residents to the building of the South Facility, including construction in the area. Councilor Lo said that there were some general concerns about constructions in terms of noise and vibration, however OPS staff have had good communications with the Councillor and residents, and will be taking steps to minimize disruptions. Overall, residents are relieved the project is going ahead with overall positive support.

Adam Joiner, Chief Executive Officer of BGC Ottawa, made a presentation on this item.

A question came up concerning the impact of the increase in interest rates, inflation, and population in Canada on the families that BGC serves.

Adam Joiner said that the resources needed to support families has increased significantly and this need continues to grow. They are seeing a significant impact on mental health and food security. The increasing need is very high compared to last year and people are coming from everywhere in Ottawa. The current resources are not enough to serve all of them.

Chief's report

A concern was raised about the impact of the multitude of events on OPS, both in terms of financial impact but also the impact on officers. The Board wants to have a better understanding of these impacts. The Service noted it has an early intervention/warning program regarding overtime that tracks key indicators that can be provided to leadership and direct supervisors if certain thresholds are being exceeded. It was noted that the Service's strategic staffing plan will help offset the need for overtime.

A comment was made regarding the shooting on Gibford Drive, the largest shooting in Ottawa in some time, and the need to ensure constant communication as people in the community are concerned.

With respect to one of the commendations from the Commendation Report, the Service clarified that it has a Mental Health Unit that is very familiar with local hospitals and the staff that work there, as well as deescalation.

8.4 Migration from the E911 Network to the NG9-1-1 Network

Chief's report

Presentation

The Service noted it is project managing its own migration to NG911 in terms of the onboarding of technology. The City has engaged a consultat to look at the whole project as the governing authority.

It was confirmed that the launch date of March 2025 is not changing and the Service should have migrated 70% by now but they are not there yet. The Service is mid-pack in terms of comparisons with other police services and is in a good position for the migration as it is taking a more progressive approach to reduce risk.

The Service does not have an estimate yet for the next and final phase but it will be less than the previous investment.

That the Ottawa Police Services Board delegate authority to the Chief of Police for the purchase of equipment and professional services from Komutel Inc. for systems upgrades which will be required before the migration of the 9-1-1 connections for both the Ottawa Police Service (OPS) and Ottawa Fire Services (OFS) from the legacy Enhanced 9-1-1 (E911) network to the new Next Generation 9-1-1 (NG9-1-1) network, as mandated by the Canadian Radio-television and Telecommunications Commission (CRTC), for the amount of \$550,990.00 before applicable taxes.

8.5 Advocating for Complainant Protections in the Proposed Rules for
Adjudication Hearings and the Regulation re the Ontario Police Arbitration
and Adjudication Commission under the Community Safety and Policing
Act (CSPA)

Presentation

It was clarified that the wording being proposed by the Service is included within the slide deck.

A question was raised concerning whether or not there is any difference between the protections within the criminal context versus administrative context and whether the Board and Service need to be careful about proposing these protections within an administrative context. The Service did not see any concerns and noted this would not be the first administrative tribunal to do so; doctors/physicians have done it. Where there is a difference is how the application is dealt with, i.e. different filing deadlines. The Service is proposing implementing a civil standard of mutual disclosure.

A request was made to adjust the motion to clarify the new *Act* is not yet in force.

A request was also made to reach out to other Boards cross the province.

That the Ottawa Police Services Board, as the employer of the Ottawa Police Service, endorse the wording, feedback and principles that the OPS is suggesting in relation to complainant protections in the proposed rules for adjudication hearings and the regulation regarding the Ontario Police Arbitration and Adjudication Commission under the Community Safety and Policing Act (CSPA) [not yet in force], including submitting joint feedback with the Service on the regulations related to complainant protections and mandatory annual adjudicator training; and directing that the Chair and Chief meet jointly with the Solicitor General or designate to request the changes be codified.

Chief's report

It was clarified that there are existing thresholds within the Board's Financial Accountabilities Procedure Manual, as well as reporting requirements.

The Service was directed to report on contracts approved under delegated authority over \$25,000 through its quarterly financial updates to the Board, separating out expenses related to South Facility.

That the Ottawa Police Services Board approve:

- 1. The reallocation and advancement of Facilities Strategic Plan project funding from Central Assessment and Elgin-C for the value of \$8,669,000, to the South Facility Project to support the execution of Phase B.2, for a total project value of \$193,715,193.
- 2. The award of a construction contract in the amount of \$115,452,850 (including construction contingency; net of HST) to Contractor Broccolini Construction Inc. for the main construction of the South Facility.
- 3. The delegation of authority to the Chief of Police to award contracts and execute payments for all remaining project related activities required to deliver the South facility project for an amount not to exceed the approved project budget.
