APPLICANT'S PROPOSAL / PURPOSE OF THE APPLICATIONS:

The Owners want to subdivide their property into two separate parcels of land to create two new lots for the construction of two single detached dwellings. The existing dwelling will be demolished.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owners require the Committee's consent to sever the land. The property is shown as Parts 1 & 2 on a Draft 4R-Plan filed with the applications and the separate parcels will be as follows:

Approval of these applications will have the effect of creating separate parcels of land. The parcels of land and one the proposed dwellings will not be in conformity with the requirements of the Zoning By-law and therefore, minor variance applications (File No. D08-02-23/A-00258 & D08-02-23/A-00259) have been filed and will be heard concurrently with these applications.

REQUESTED VARIANCES:

The Owners/Applicants require the Committee's authorization for minor variances from the Zoning By-law as follows:

A-00258: 44 A Dunham Street, Part 1 on 4R Plan, proposed detached dwelling:

- a) To permit a reduced lot area of 408.9 square metres, whereas the By-law requires a minimum lot area of 450 square metres.
- b) To permit a reduced rear yard setback of 9.18 metres, whereas the By-law requires a minimum rear yard setback of 10 metres.

A-00259: 44 B Dunham Street, Part 2 on 4R-Plan, future detached dwelling:

- c) To permit a reduced lot area of 407.7 square metres, whereas the By-law requires a minimum reduced lot area of 450 square metres.

THE APPLICATION also indicates that the Property is not the subject of any other current application under the *Planning Act*.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

Information you choose to disclose in your correspondence, including your personal information, will become part of the public record, and shared with Committee Members, the Applicant(s) or their agent, and any other interested individual.

You will receive details on how to participate by videoconference. If you want to share a visual presentation, the Coordinator can provide details on how to do so. Presentations are limited to five minutes, and any exceptions are at the discretion of the Chair.

Hearings are governed by the Committee of Adjustment's *Rules of Practice and Procedure* accessible online.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
