APPLICANT’S PROPOSAL AND PURPOSE OF THE APPLICATION:

The Owner wants to convey a portion of its property to the abutting property owner to the south, known municipally as 8611 Purdy Road.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owner requires the Committee’s consent for a lot line adjustment.

The severed land, shown on a sketch filed with the application, will have a frontage of 237 metres, a depth of 136 metres and will contain an area of 2.3 hectares. This parcel contains four accessory structures and will be merged with the property known municipally as 8611 Purdy Road.

The retained land, shown on said sketch, will have a frontage of 163 metres, a depth of 1620 metres, and will contain a lot area of 106 hectares. This parcel contains vacant farmland and is municipally known as 8601 Purdy Road.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
