The development, maintenance, and enhancement of the streetscape urban design elements and lighting systems is essential to creating a unique day and evening setting for the Ottawa citizen's and visitors.

ANNUAL HIGHLIGHTS

In this past difficult COVID-19 year, the restaurants and businesses mobilized an outdoor summer patio street closure from May to mid-September 2022, which was very successful. Most of our restaurants had an outdoor patio with a maximized but safe seating capacity. The closing of the street over the weekends was instrumental to businesses survival. The customers seemed very pleased with the layout claiming it had a very European feel. We thank the Councillors, Alderman, Mayor and staff for their assistance over this difficult year.

FINANCIAL HIGHLIGHTS

The ongoing engagement of a part time BIA manager, and the mobilizing of funds beginning in 2023 for the annual renewal and upgrading of the streetscape lighting.
