 That Councillor Wilson Lo attend the Association of Municipalities of Ontario (AMO) Annual Conference to be held August 20 to August 23, 2023, in London, Ontario, in addition to the Mayor and Councillor Brockington, who was previously appointed by Council to serve as the City's AMO representative;

### **BACKGROUND**

The City of Ottawa is the fourth largest city in Canada, the second largest city in Ontario, and the largest city in the Association of Municipalities of Ontario (AMO). In addition to AMO, the City is a member of a number of municipal organizations including the Federation of Canadian Municipalities (FCM), the Rural Ontario Municipal Association (ROMA), and the Association of Francophone Municipalities of Ontario (AFMO).

With greater emphasis being placed on stronger municipalities, the work of these organizations intensifies as they are the bodies responsible for advancing policies and negotiating agreements with the upper levels of government. The City of Ottawa can

influence in this policy development and negotiations through participation in these organizations. To this end, Members of Council are invited to attend various conferences, conventions, and meetings both within and outside the municipality.

In March 2008, the Participation in Municipal Organizations and Miscellaneous Internal Issues report (ACS2008-CMR-CCB-0040) was approved. This report set out guidelines and protocols for participation in municipal associations. Specifically, the guidelines required that a comprehensive report be prepared early in each calendar year identifying the primary municipal conferences and the recommended delegates for each conference.

The Finance and Corporate Services Committee has the authority to approve travel and attendance at the AMO and FCM annual conferences, and other conferences that do not fall within the mandate of other Standing Committees, as required.

On November 30, 2022, Council appointed Councillor Tim Tierney as the City's representative to FCM until the 2023 Annual Conference and Trade Show. On December 7, 2022, Council further appointed Councillor Riley Brockington as the City's representative to AMO until the 2022-2026 Mid-Term Governance Review.

### **DISCUSSION**

In accordance with past practice, all Members of Council were canvassed for their interest in representing the City of Ottawa at the FCM Annual Conference and Trade Show and the AMO Annual Conference.

### **FCM Annual Conference**

The Federation of Canadian Municipalities (FCM) is hosting its Annual Conference and Trade Show from May 25 to May 28, 2023, in Toronto, Ontario.

The Office of the City Clerk solicited interest for up to five (5) Members, in addition to Mayor Sutcliffe and Councillor Tierney, as the City's FCM representative. Following expressions from five Members, the Office of the City Clerk is recommending that Councillors Bradley, Devine, Lo, Menard and Troster attend in person with Mayor Sutcliffe and Councillor Tierney for a total of seven delegates.

#### **AMO Annual Conference**

The Association of Municipalities of Ontario (AMO) is hosting its Annual Conference from August 20 to August 23, 2023, in London, Ontario.

The Office of the City Clerk solicited interest for up to five (5) Members, in addition to Mayor Sutcliffe and Councillor Brockington, as the City's AMO representative. The Office of the City Clerk is recommending that Councillor Lo attend in person with Mayor Sutcliffe and Councillor Brockington for a total of three delegates.

Funds are available within the 2023 Elected Officials Administration operating account.

### CONSULTATION

The Office of the City Clerk solicited Members of Council for interest in representing the City at various municipal organizations. Member interest and preferences were considered by the Nominating Committee in its deliberations and appointments on December 14, 2022.

Members were further consulted by the City Clerk through the circulation of a memo to solicit interest in attending the 2023 FCM Annual Conference and Trade Show, and the 2023 AMO Annual Conference.

### DISPOSITION

Council Support Services will process the registrations for the 2023 FCM Annual Conference and Trade Show, and the 2023 AMO Annual Conference, and advise FCM and AMO of the City's delegates.

As the early-bird registration deadline for AMO is March 3, 2023, and that FCSC will not yet have considered this report on recommended delegates, all Members who signal their interest in participating will be proactively registered to benefit from preferential pricing. Council Support Services will cancel registrations for a full reimbursement less a small administrative fee in the event a Member is not approved as a delegate.

Should any Member of Council be unable to attend a conference for which they have been registered, it is requested that they notify the City Clerk immediately. The City Clerk will undertake a circulation to all Members of Council to identify a substitute.

As per the 2008 Council-approved report entitled *Participation in Municipal Organizations and Miscellaneous Internal Issues*, if the City is unable to identify a substitute and unable to obtain a full refund in the event of a cancellation that is not the result of an emergency, outstanding registration fees will be charged to the Member's Constituency Services Budget. Delegates to each of the conferences are responsible for making their own travel and accommodation arrangements, with the support of Council Support Services.

Similarly, the cost of registration for any additional Members who advise the City Clerk at a later date of their intent to attend these conferences will be charged to the respective Member's Constituency Services Budget.

The Council Expense Policy requires Members who undertake City-funded travel to submit a written report to the appropriate Standing Committee detailing their experiences, what they learned and how the City's position or interests were advanced. The report will be included on the agenda of the appropriate Standing Committee as an Information Previously Distributed (IPD) Memo.

The Finance and Corporate Services Committee has the delegated authority to approve this report in accordance with its Terms of Reference.
