REPORT RECOMMENDATION(S)

That the Joint Meeting of Transit Commission and Light Rail Sub-Committee receive this report for information.

RECOMMANDATION(S) DU RAPPORT

Que la réunion conjointe de la Commission du transport en commun et du Sous-comité du train léger reçoive ce rapport pour information.

BACKGROUND

At its meeting of December 7, 2022, during Governance Review approvals, Council approved a motion from Councillor Brockington that directed staff to offer each Union representing OC Transpo employees an opportunity to provide a presentation at Transit Commission every year, and to host two informal sessions between the Transit Commission, OC Transpo Management, and Union executives during the 2022-26 Term of Council.

The motion states:

BE IT RESOLVED that Transit Commission host two informal sessions between the Transit Commission, OC Transpo Management and Union executives that represent OC Transpo employees during the 2022-2026 Term of Council (this would be similar to a 'Meet and Greet' and not a formal sit-down); and

BE IT FURTHER RESOLVED that a formal segment on the Transit Commission's agenda be created whereby each Union representing OC Transpo employees be afforded the opportunity, once a year, to provide a presentation on their members main issues / concerns.

In accordance with Council's direction, Transit Services has raised this matter with union leadership and extended the invitation to each union representing Transit employees to attend the December 14, 2023, meeting of the Transit Commission.

DISCUSSION

OC Transpo Management has extended an invitation to attend the December 14, 2023, Transit Commission meeting to deliver a presentation on their members' issues and answer questions from Councillors. The following unions have been invited:

- Amalgamated Transit Union, Local 279;
- Amalgamated Transit Union, Local 1760;
- Canadian Union of Public Employees, Local 5500; and
- Civic Institute of Professional Personnel (CIPP),

Staff will also ensure that Council's direction to host two informal sessions is met, with the first session expected to take place in 2024.

CONSULTATION

OC Transpo management has discussed the intent of the motion (No. 2022-03/09) with union leadership and provided some guidance on how to provide information to Transit Commission.
