Direction to staff (Vice-Chair J. Bradley)

In relation to Recommendation 3 (\$35,000 to support free youth access to City fitness facilities as outlined in the report), that staff be directed to ensure that the program be barrier-free, with no application process for funding for those youth as long as they qualify within the age bracket.
