- 8. Inquiries
 - 8.1 City of Ottawa Spay/Neuter Clinic

Submitted by Councillor S. Devine (Inquiry EPPSC 2023-06)

The HolliBell Foundation is a registered not-for-profit (in the process of obtaining charitable status) whose mission is to promote animal welfare through funding the spaying and neutering of domestic, feral and stray animals, which helps both the community as a whole and individual residents. Similar to the City's Spay/Neuter Clinic, the objective of sterilizing these animals is to control population growth and reduce the number of unwanted animals in need of shelter and care. The Foundation is currently using the facilities of a spay neuter clinic in Brockville.

As the city of Ottawa's Spay & Neuter Clinic is currently open for surgeries only 4 days per week, the Foundation has expressed interest to the City in accessing its Spay/Neuter Clinic facilities during the days it is not currently operational in order to expand its animal sterilization efforts in the Ottawa area.

Recently, the Hollibell Foundation and other individuals and residents have made inquiries about whether Ottawa's Spay & Neuter Clinic can be made available for the other 2-3 days per week when the clinic is not operational, should another licensed veterinarian and/or credible organizations have the capacity to deliver professional services, and assuming the additional costs could be covered by other parties.

Recognizing that there may legislative barriers in this regard and that the current Spay/Neuter Clinic's own veterinarian is operating at capacity, could staff review the feasibility and costs of expanding the current Clinic facilities and operation to other parties in order accommodate additional surgeries at a time when issues of animal control is a growing concern.
