APPLICANTS'S PROPOSAL / PURPOSE OF THE APPLICATIONS:

The Owners want to subdivide their property into two separate parcels of land to create one new lot for future development. The existing dwelling will remain on the severed parcel.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owners requires the Committee's consent to sever.

The severed property is shown on a sketch filed with the application, will have a frontage of 42.78 metres, a depth of 71.88 metres and a lot area of 3075 square metres. This parcel contains the existing dwelling and will be municipally known as 1086 Thomas Dolan Parkway.

The retained property is shown on said sketch, will have a frontage of 72.72 metres on Thomas Dolan Parkway and 70.79 metres on Dunrobin Road, an irregular depth of 71.77 metres and a lot area of 5023.5 square metres. This parcel is vacant and is municipally known as 2750 Dunrobin Road.

THE APPLICATION INDICATES the property isn't subject to any other current applications under the *Planning Act*.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
