### APPLICANTS PROPOSAL / PURPOSE OF THE APPLICATION:

The Owners want to construct a detached garage at the rear of their property, as shown on plans filed with the Committee.

### REQUESTED VARIANCES:

The Owners/Applicants require the Committee's authorization for minor variances from the Zoning By-law as follows:

- a) To permit an increased cumulative floor area of 100.34 square metres, whereas the By-law permits a maximum cumulative floor area of 55 square metres.
- b) To permit an increased building height for an accessory structure of 4.918 metres, whereas the By-law permits a maximum building height for an accessory structure of 4.5 metres.

**THE APPLICATION** indicated the property isn't subject to any other current applications under the *Planning Act*.

**IF YOU DO NOT PARTICIPATE** in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

**IF YOU WANT TO BE NOTIFIED OF THE DECISION** following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
