PURPOSE

The purpose of this memorandum is to report to Transportation Committee on the use of delegated authority in 2023 by the Transportation Planning Service Area.

BACKGROUND

A new Delegation of Authority By-law (2023-67) was enacted by Council on March 8, 2023. Schedule "I" of the By-law pertains to the Planning, Real Estate and Economic Development Department, and delegates several responsibilities related to transportation. The use of delegated authority with respect to these items must be reported to the appropriate Standing Committee (i.e. Transportation Committee) at least once in each calendar year.

DISCUSSION

To meet the reporting requirements as identified in the Delegation of Authority By-law (2023-67), the Transportation Planning Service Area has produced a consolidated list which highlights their use of delegated authority in 2023 (see Document 1).

CONCLUSION

Transportation Planning will continue to report to Transportation Committee once per year on their use of delegated authority as per the current Delegation of Authority By-law (2023-67).

Transportation Planning – Capital Projects

The following roadway modifications were approved in 2023 under Section 40 – Intersection and Road Modifications of Schedule “I” of By-law 2023-67. The approvals for these functional design studies are for projects initiated by the Transportation Planning Service Area, including projects from the Intersection Control Measures and Network Modification programs. Projects stemming from Integrated Road-Water-Sewer Renewal are also included. These projects all have Council-approved capital budgets. Infrastructure Services in the Infrastructure and Water Services Department manages the construction of these projects, as well as the capital budget of the renewal program.

The approvals for these projects were sought by the Transportation Engineering Services Branch of Transportation Planning for projects stemming from new private developments. The construction of these projects is managed by development proponents with inspections completed by City staff.

Additions to the Winter-Maintained Cycling Network

By-law 2023-67, Schedule “I”, Section 36 – Encroachments delegates authority to the General Manager, Planning, Real Estate and Economic Development, in consultation with the General Manager, Public Works, to modify the Winter Cycling Network as each cycling project is completed in accordance with winter cycling needs, connectivity, and affordability.

The following RMA (Road Modification Approval) involves an addition to the Winter Maintained Cycling Network:

- RMA-2023-TPC-024 Scott Street Cycle Tracks.

Notable additions made to the Winter Maintained Cycling Network in 2023 include:

- Wellington Street/Rideau Street, from Bay Street to Sussex Drive,
- Montreal Road, from Vanier Parkway to St-Laurent Boulevard, and
- Mark Avenue, from Greensway Avenue to North River Road.
