Public delegations spoke to OPS use of force statistics and disproportionality, general occurrence reports and a lack of policy to challenge them, auto theft, and demonstrations and over policing.

It was clarified with respect to one delegation's comments that the *Police* Services Act does not permit criminal defence lawyers to be members of Police Services Boards.

In terms of the delegation focused on demonstrations and over policing, the Board confirmed it would be completing a review of its major events policy.

The Service noted that they are doing their best with limited resources to combat vehicle theft. There are two main challenges when dealing with car theft which are the technology used by the thieves and organized crime. They are cooperating with the Canada Border Services Agency (CBSA) and other partners.

8.3 <u>Update on Demonstration Activity</u>

Presentation

The Service noted that they are continually improving their response and are open for feedback. They are seeing an unprecedented level of demonstrations in Ottawa that require a significant effort to manage. They are always adjusting and changing their strategies. Frontline officers are working long hours and dealing with verbal and physical abuse from some protestors.

In terms of the miscommunication that recently occurred between OPS and Bylaw and what is being done to prevent this from happening in the future, the Service noted they recently had Bylaw review a message before it went out to the public.

In terms of discretion used when issuing megaphone and roadway tickets, the Service noted they employ a scalable approach where they will issue lots of warnings. They ensure coordination with Bylaw services and also employ enforcement when it is safe to do so, so as to not create more issues if not needed.

In terms of megaphone use, the Service advised that profanity and hate speech is not allowed. Further, if the megaphone is brought in the vicinity of a Bylaw or police officers head, it may elicit an enforcement response if the activity continues.

The Service has many conversations with organizers before events to lay out ground rules. Sometimes people will go into crowds and go against the agreements reached between police and organizers; there are some people who have a different agenda than the rest of peaceful organizers.

In terms of charges for blocking a roadway, the Service noted they may do so if demonstrators block a highway or roadway and refuse to move. If disruptions are brief and controlled, the Service can coordinate with demonstrators and plan accordingly.
