APPLICANT'S PROPOSAL / PURPOSE OF THE APPLICATION:

The Owner wants to construct a new coach house to the rear (south) of the existing detached dwelling, as shown on plans filed with the Committee.

REQUESTED VARIANCES:

The Owners/Applicants require the Committee's authorization for minor variances from the Zoning By-law as follows:

- a) To permit an increased height for a building containing a coach house of 4.04 metres, whereas the By-law permits a maximum building height of 3.6 metres.
- b) To permit an increased footprint for a building containing a coach house of 101 square metres, whereas the By-law permits a maximum building footprint of 80 square metres.
- c) To permit an increased lot coverage of 28%, whereas the By-law permits a maximum lot coverage of 15%.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

Information you choose to disclose in your correspondence, including your personal information, will become part of the public record, and shared with Committee Members, the Applicant(s) or their agent, and any other interested individual.

Presentations are limited to five minutes, and any exceptions are at the discretion of the Chair.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers*

Procedure Act, including consents to sever land and minor variances from the zoning requirements.
