APPLICANTS PROPOSAL / PURPOSE OF THE APPLICATION:

The Owners want to convert the existing two-storey, semi-detached dwelling into a low-rise apartment building with 8 units in total. They are proposing to add a third storey and to construct a three-storey addition at the rear, as shown on the plans filed with the application.

REQUESTED VARIANCES:

The Owners require the Committee's authorization for minor variances from the Zoning By-law as follows:

A-00292 454 Nelson Street:

- a) To permit a reduced interior side yard setback (north) of 0.90 metres, whereas the By-law requires a minimum interior side yard setback of 1.50 metres.

- b) To permit a reduced rear yard setback of 8 metres, or 25.9% of the lot depth, whereas the By-law requires a minimum rear yard setback of 30% of the lot depth, or in this case, 9.11 metres.

A-00293 456 Nelson Street:

- c) To permit a reduced interior side yard setback (south) of 0.287 metres, whereas the By-law requires a minimum interior side yard setback of 1.50 metres.

- d) To permit a reduced rear yard setback of 8 metres, or 25.9% of the lot depth, whereas the By-law requires a minimum rear yard setback 30% of the lot depth, or in this case, 9.11 metres.

THE APPLICATIONS indicate that the Property is not the subject of any other current application under the *Planning Act*.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

Presentations are limited to five minutes, and any exceptions are at the discretion of the Chair.

Hearings are governed by the Committee of Adjustment's *Rules of Practice and Procedure* accessible online.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
