#### REPORT RECOMMENDATION(S)

That Built Heritage Committee recommend that Council removes reference to the properties listed in Document 1, attached to this report, from the Municipal Heritage Register.

#### **RECOMMANDATION(S) DU RAPPORT**

#### **BACKGROUND**

This report follows directions from report <u>ACS2023-PRE-RHU-0019</u> which established the Heritage Planning Branch's strategy for the implementation of Bill 23's legislative amendments to the *Ontario Heritage Act* along with associated procedural and administrative changes.

#### **Municipal Heritage Register**

Section 27 (3) of the *Ontario Heritage Act* allows municipalities to list non-designated properties of cultural heritage value or interest on a municipal heritage register. Listing on a municipal heritage register provides interim demolition protection for properties. If a property owner wishes to demolish a building or structure located on a non-designated property listed on a municipal heritage register, Section 27 (9) of the *Ontario Heritage Act* requires that they provide 60 days' notice, in writing, of their intent to demolish.

The Province of Ontario's Bill 23 introduced new restrictions to the listing of non-designated properties which came into effect on January 1, 2023. Non-designated properties can be listed on a municipal register for a maximum of two years, whereas prior to these amendments a non-designated property could be listed indefinitely. If a listed non-designated property is not designated or subject to an active Notice of Intention to Designate at the two-year anniversary of its listing date it must be removed from the heritage register and cannot be listed again for a period of five years.

#### Review of Non-Designated Properties Listed on Ottawa's Heritage Register

As set out in recommendation 1 (A) of report ACS2023-PRE-RHU-0019 Heritage Planning staff have conducted a phased review of the non-designated properties listed on the City's heritage register. Phase I of this review involved a "Yes" or "No" assessment using existing municipal heritage data to identify candidate properties for individual heritage designation. Properties that received a "Yes" were deemed candidates for individual designation and moved on to Phase II, which is the ongoing

prioritization, researching, and potential designation of these candidate properties. Properties that received a "No" were not identified as individual designation candidates.

#### Removal of Listed Non-Designated Properties from Heritage Register

This report's recommendation follows the direction established by recommendation 1 (B) in report ACS2023-PRE-RHU-0019. This directs staff to commence the phased removal of listed, non-designated properties from the City of Ottawa's Municipal Heritage Register in advance of their legislated removal after December 31, 2024 via the provisions of *Ontario Heritage Act* section 27 (15) and (16). This report is the first of several anticipated reports which will remove the majority of listed, non-designated properties from the Municipal Heritage Register. The intent of removing properties in phases is to gradually bring Ottawa's Municipal Heritage Register into compliance with the post-Bill 23 intent of the Ontario Heritage Act, which has shifted the Municipal Heritage Register from a more passive commemoration and monitoring tool to an active and fluctuating interim conservation tool tied directly to development processes regulated by the *Planning Act*. To assist with the notification and scheduling of affected Ward Councillors, and to ensure capacity for consultation with the Built Heritage Committee, properties identified for removal from the Heritage Register are being brought forward in batches. The first three register removal reports will be organized by Ward, with subsequent removal reports following the completion of related Bill 23 implementation work including the forthcoming Heritage Conservation District (HCD) study area workplan report.

Removing properties from the Municipal Heritage Register in advance of December 31, 2024 retains Council's ability to re-list properties, whereas listed properties removed by the processes of Ontario Heritage Act section 27 (15) or (16) are prohibited from relisting for a period of five years. Heritage staff are not recommending the mass re-listing of properties removed from the Municipal Heritage Register but may pursue the relisting of certain properties when appropriate, in accordance with the revised provisions of the Ontario Heritage Act. Non-designated properties are now subject to the "Criteria for Determining Cultural Heritage Value or Interest" set out in Ontario Regulation 9/06 which requires them to meet one or more of the nine prescribed criteria to be listed on the Municipal Heritage Register. This requirement matches the pre-Bill 23 test for designation of a property under Part IV of the Ontario Heritage Act. Given this higher threshold for listing properties on the municipal heritage register, staff's opinion is that retaining the ability to re-list properties by removing them prior to the December 31, 2024, deadline is appropriate and ensures that the Municipal Heritage Register can be implemented as intended by the Province. Staff note that a property being removed from the Municipal Heritage Register via any process does not prohibit its designation under Part IV or V of the Ontario Heritage Act.

#### DISCUSSION

# Recommendation 1: Remove reference to the properties listed in Document 1 from the City's Municipal Heritage Register.

The City of Ottawa's Municipal Heritage Register contains approximately 4600 listed, non-designated properties. Heritage staff have undertaken a comprehensive review of the existing Municipal Heritage Register, as detailed in report ACS2023-PRE-RHU-0019 along with outreach to Ward Councillors, engagement with community associations and other organizations, and online engagement via Engage Ottawa – to identify properties as potential candidates for designation under Part IV or Part V of the Ontario Heritage Act and to develop a research workplan. Properties not identified as potential designation candidates will be removed from the register. This first report recommends the removal of properties from the following Wards: 1, 2, 4, 5, 6, 19, 20, 21, 22, 23, and 24. The properties recommended for removal from the heritage register by this report were screened as part of the Phase I heritage register review detailed in recommendation 1 (A) of report ACS2023-PRE-RHU-0019 and were not identified as candidates for individual designation. In total, this report recommends the removal of 465 properties from the Municipal Heritage Register. The recommended removals are summarized by Ward in Document 1. The removal of a property from the municipal heritage register does not preclude its future designation under Part IV or V of the Ontario Heritage Act. Properties in the above-noted Wards which remain listed on Ottawa's municipal heritage register may be removed in subsequent reports over the course of 2024.

#### **Heritage Register Data**

Recommendation 3 (b) in report ACS2023-PRE-RHU-0019 directs staff to create a new development monitoring tool and public heritage information resource. As an interim measure, existing publicly-accessible data related to properties removed from the heritage register through this report will remain available online through GeoOttawa. Properties removed from the Heritage Register will be identified on GeoOttawa with a unique symbol and labeled as "Former Heritage Register Listing". The intent of this temporary approach is to maintain public access to existing heritage data while a more permanent solution is developed. Heritage staff will bring forth recommendations in an upcoming report to fully implement this direction.

#### FINANCIAL IMPLICATIONS

There are no direct financial implications.

#### **LEGAL IMPLICATIONS**

There are no legal impediments to approving the recommendation in this report.

#### COMMENTS BY THE WARD COUNCILLOR(S)

Affected Ward Councillors are aware of the recommendations of this report.

#### CONSULTATION

There are no accessibility impacts associated with this report. Staff have ensured that related project material distributed publicly is available in an accessible form and will accommodate any further accessibility needs should they arise.

There are limited risk implications. These risks have been identified and explained in the report and are being managed by the appropriate staff

#### ASSET MANAGEMENT IMPLICATIONS

There are no asset management implications.

#### **RURAL IMPLICATIONS**

This report recommends the removal of some rural properties from the City of Ottawa's municipal heritage register. These properties will no longer be subject to the heritage register provisions of the *Ontario Heritage Act*.

#### TERM OF COUNCIL PRIORITIES

There are no direct impacts to the 2023-2026 Term of Council Priorities. The intent of this report is to bring the City's heritage planning program into compliance with the requirements of the Ontario Heritage Act, as amended by Bill 23.
