REPORT RECOMMENDATION

That the Agriculture and Rural Affairs Committee recommend Council approve the amendment to By-law 2004-293 respecting fence-viewing fees, to refer to By-law 2024-33, as outlined in Document 1.

RECOMMANDATION DU RAPPORT

BACKGROUND

The *Line Fences Act, R.S.O. 1990, c.L.17*, provides a mechanism whereby a landowner who wishes to have a fence constructed to mark the boundary between their land and that of an adjoining owner or, where a fence already exists, to have it repaired or reconstructed, and who has not entered into a written cost sharing agreement with the adjoining owner, may arrange with the municipality to have fence-viewers view and arbitrate as to what portion of the fence each owner shall construct, reconstruct or repair and maintain. The *Act* also provides that the council of every local municipality shall, by By-law, appoint such number of fence-viewers as are required to carry out the provisions of the *Act*, and to set the fees associated with fence-viewing.

In 2004, the City of Ottawa passed By-law 2004-439, which is Ottawa's line fences by-law. This By-law is administered by the Rural Affairs Office.

DISCUSSION

In 2019, the fees for fence-viewing were set by Planning Infrastructure and Economic Development's planning fee schedule for the first time, and By-law 2004-293 was amended by By-law 2019-415 to refer to the planning fee schedule with a fee of \$400.00. Since that time, whenever there has been a new planning fee structure adopted, a new amending by-law is required to ensure that By-law 2004-293 refers to the proper, active by-law regarding fence-viewer fees.

On December 6, 2023, the 2024 City budget was adopted. Following the adoption of the Budget, By-law 2024-33 was adopted on January 24, 2024. This By-law set the planning fees for the City of Ottawa for the year. Now that By-law 2024-33 has been adopted, the previous fee by-law is rescinded and a new by-law to amend By-law 2004-439, section 3, is required to update the fees charged for fence-viewing. The attached by-law will amend By-law 2004-293 to refer to By-law 2024-33 for fence-viewing which

set the fee at \$430.00 per fence-viewing. The fees charged are revenue neutral and cover the costs associated with fence-viewing.

Document 1 – Enacting By-law

BY-LAW NO. 2024 -

A by-law of the City of Ottawa to amend By-law No. 2004-293 respecting the fee for fence-viewing.

The Council of the City of Ottawa, pursuant to Section 2 of the *Line Fences Act*, R.S.O.1990, enacts as follows:

1. That Section 3 of the said By-law No. 2004-293 is replaced with the following Section: "3. Where an application is made under the Line Fences Act, an administrative fee, as set out in By-law 2024-33, as amended, shall be paid to the City at the time the application is submitted."
